Prison commenced as a result of the judicial reforms introduced by Kameron in British Imperialist Era in 1832. Welikada Prison was established compatible with British Borstal System in terms of the Legal and Court Ordinance no. 18 of 1844. By the Prison Act no.16 of 1877, this service was structured and regulated under a separate department directly under control of the Commissioner of the Prisons with the effect from 16th July, 1905. With development of the society, this service turn out to be very crucial. As a result, the Mahara Prison was built in 1875 and the Bogambara Prison which was in the form of the "Been Field' Prison in England was constructed in 1876. Today, the prison evolved this way, has become an essential and specific institute before the complexity of present day society. Accordingly, the prison system consists of 03 closed prisons, 19 remand prisons, 02 correction centers for youthful offenders, 01 training centre for youthful offenders, 09 work camps, 02 open prison camps, 23 prison lockups and 01 prison school are under the control of Superintendentents of Prisons. There are about 19,000 inmates under their custody.

This department comes under the Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religious Affairs cared and secured inmates, today it has gone beyond the limit of it and become a social correctional center that rehabilitates inmates. This performance report illustrates the endeavor of rehabilitating and socializing inmates as good citizens by the Department of Prisons as a social adaptation body in the year 2017.

5.1 Welikada Prison Complex.

Since the land area of 13.4077 Ha where Open Prison Camp- Kandewatta situated, has been recognized to relocate Welikada Prison, letter has been sent to the Ministry of Law and Order to obtain a observational report on security measures in constructing a new prison and escorting prisoners to courts. In addition, It is expected to obtain NBRO, EIA Reports and contour plan and relevant institutes have been already informed.

Urban Development Authority has agreed to provide a building for relocating Prison Headquarters under Sethsiripaya Stage 111.

5.2 Relocating Galle Prison

Preparing Master Layout Plan by the committee appointed by the Department of Prisons together with the State Engineering Corporation appointed by the Prime Minister's Office for consultation services of designing master layout plan is in its final stage. Draft estimated expenditure is 2.08 Billion. Drafted Consultancy Services Agreement is being studied for further proceedings. Detailed drawing will continue after the cabinet approval.

5.3 Relocating Matara Prison

Master Layout Plan is in its final stage designed by the committee appointed by the Department of Prisons together with State Engineering Corporation for consultancy services appointed by Prime Minister's Office. Draft estimated expenditure is 1.92 Billion. and approved from the Department of National Planning has been granted. Drafted Consultancy Services Agreement is being studied before for the further proceedings. Detailed drawing will continue after the cabinet approval.

5.4 Relocating Batticaloa Prison

Master Layout Plan and the Estimate was prepared by the Committee appointed by the Department of Prisons together with Urban Development Authority appointed by the Prime Minister's Office for consultancy services. Draft estimated expenditure is 1.6 Billion and drafted Consultancy Services Agreement is being studied before signing. Once the drafted master layout plan is in accordance with committee approval the approval from the Department of National Planning will be seek for further proceedings.

5.5 Relocating Trincomalee Prison.

Master Layout Plan and the Estimate was prepared by the Committee appointed by the Department of Prisons together with Urban Development Authority appointed by the Prime Minister's Office are for consultancy services. Draft estimated expenditure is 1.2 Billion and drafted Consultancy Services Agreement is being studied before signing. Once the drafted master layout plan is in accordance with committee approval the approval from the Department of National Planning will be seek for further proceedings.

4. Information Technology Division

In accordance with the prison system evolved gradually along with the complexity of the society where is a high demand on the security of prisoners' information. It will be very much important to Administrate the inmates related activate efficiently and effectively along with introduction of Prisoners Information Management System under the software development.
