General Instructions and Conditions for the Registration of Suppliers/Contractors under the Shopping Method

1. To register as a supplier or contractor for the Department of Prisons for the year 2026 under the Shopping Method, relevant documents can be downloaded free of charge from December 30, 2025, to January 14, 2026 by visiting <http://prisons.gov.lk> and navigate to the "Other/ Notices" section or applications can also be obtained from the Prison Headquarters or any prison institution.
2. Applicants, always are requested to provide only accurate information. If it appears that any information provided is false or that important information has been withheld, such applicant will be disqualified from registration. Incomplete or unclear applications will be rejected.
3. All documents attached to the application must be numbered sequentially. The total number of pages must be clearly stated in the top right-hand corner of the main application.

The following documents must be attached to the application:

- a.** A copy of the Business Registration Certificate or Company Registration Certificate.
- b.** All suppliers/contractors must have at least three (03) years of experience in the field relevant to the goods or services they are applying for. Documents proving this experience must be submitted.
- c.** Contractors applying for civil engineering construction works must attach a copy of their certificate confirming the specific category/grade under which they were last registered with the Construction Industry Development Authority (CIDA).
- d.** The original copy of the cash deposit slip or receipt for the payment of registration fees per item must be attached.
- e.** Individuals or businesses registered for VAT must submit a copy of the VAT registration certificate.
- f.** If you intend to register items related to vehicle repairs, you must submit details regarding qualifications of your institution's trained staff and a list of available equipment and tools.

4. Completed applications, along with all relevant documents, must be submitted by 2:00 PM on or before January 14, 2026 to the address, "Commissioner General of Prisons, Department of Prisons, No. 150, Baseline Road, Colombo 09" by registered post or by hand placed in the Tender Box kept at the Supplies Division of the Prison Headquarters or by hand, placed in the Tender Boxes kept at respective Prison Institutions. The top left-hand corner of the envelope must be clearly mentioned "Registration of Suppliers for the Year 2026."

5. General Instructions for Applicants

- For any item that is not applicable to the applicant, mention "N/A" (Not Applicable) in the space provided.
- If there is a change or amendment in the postal address of a company/institution after registration, such requests will only be considered if a true copy of the revised certificate issued by the relevant authority regarding the change is submitted along with the request.
- Please note that no changes to the type of items can be made under any circumstances after registration, and exchanging between items is not permitted.
- The Department of Prisons shall not be held responsible for any delays or negligence on the part of the applicant.

6. A non-refundable deposit of Rs. 500.00 must be paid for each item per each prison institution to the shroff at the Prison Headquarters or any prison institution on working days between 08:30 AM and 03:00 PM (15:00 hrs) and the original receipt must be attached to the application. (Applicants who intend to register for more than one main item listed under "Supplies" (Items 1-15) and more than one item listed under "Services and Works" (Items 1-42) must pay a fee of Rs. 500.00 separately for each main item under "Supplies" and Rs. 500.00 separately for each item under "services and works. Furthermore, applicants wishing to register for more than one prison institution must also pay the above-mentioned fees separately for each respective prison institution.) Applications submitted with cheques or money orders will be rejected.

8. Except for special circumstances, price quotations are called based on the list of registered suppliers. Since this list is revised only once a year (unless special conditions arise), it is essential for all parties interested in providing prices for the aforementioned supplies and services to register.

9. Suppliers must provide quotations to the satisfaction of the Commissioner General of Prisons and suppliers or service providers who fail to supply orders after they have been accepted will be blacklisted/removed from the list. Institutions that have repeatedly failed to respond to previous price calls or failed to deliver orders in the past will not be considered for registration. The Commissioner General of Prisons reserves the right to accept or reject incomplete applications for registration without providing any reason.

10. The final decision regarding the registration of suppliers for the year 2026 remains with the Commissioner General of Prisons.
