**Registration of Attorneys-at-Law to serve as Disciplinary Inquiry Officers  
in formal disciplinary inquiries conducted in respect of public officers**

Applications are called for the Pool of Disciplinary Inquiry Officers consisting of Attorneys-at-Law, in accordance with the provisions stipulated in Subsection 19:5 of Chapter XLVIII, Volume II of the Establishments Code of the Democratic Socialist Republic of Sri Lanka.

**Qualifications:-**

01. The candidate must possess over ten years of professional experience as an attorney-at-law and not exceed 65 years of age.
02. The certificate issued by the Supreme Court confirming that the attorney-at-law is in good professional standing (Letter of Good Standing) must be submitted as an attachment with the application.

**N.B.:-**

- (I) Selection to the pool shall be carried out by a committee appointed by the Secretary of the Ministry, and removals shall be conducted in accordance with the provisions set out in Sub-sections 19:11, 19:12, and 19:13 of Chapter XLVIII, Volume II of the Establishments Code.
- (II) The certificate mentioned in No. 02 above must be submitted every 05 years along with the covering letter (Annex 02). Attorneys-at-law who fail to do so will be removed from the pool until such time as it is submitted.

Attorneys-at-law possessing the above qualifications who wish to register as Disciplinary Inquiry Officers should accurately complete the application form obtained from the website of the Ministry of Public Administration, Provincial Councils and Local Government ([www.pubad.gov.lk](http://www.pubad.gov.lk)) and forward it to the address mentioned below.
